# Young and talented? ESADE is waiting for you



ESADE has its own admission process, independent of the pre-enrolment process for state-owned universities.

## WHO CAN APPLY?

The process is open to everyone. Submit your application if you are a talented student with the will to achieve your personal and professional goals, and you are in the last year of secondary education regardless of your school specialization.



## REQUIREMENTS

1. Outstanding academic record in your school-leaving examinations.
2. A pass in the June university entrance examination.
3. Proof of a good level of English: TOEFL 93+, IELTS 6.5+, Certificate in Advanced English 183/ C+ CAE, PTE Academic 64+.
4. Mathematics: If you want to take the Economics minor, Mathematics is required, equivalent to Math SL and HL within the IB. No Mathematics required for Politics minor.

Students who have not taken math in high school, or do not have the minimum level required, may take an exam at the end of the first year of the degree, which if passed, would give them access to the Economics Minor.

## WHEN?

The admission process is ongoing and is conducted prior to completion of the final year of secondary education. Definitive admission will depend on the candidates' fulfilment of the requirements.

The Admissions Committee can ask the candidate to attend a personal interview as part of the process.

# Two tracks to choose from: Global Economics or Global Politics



In second year you will be required to decide whether you want to channel your degree towards the area of Politics or Economics. During first year you will have taken subjects related to both worlds, so by the time you reach second year you will be in a position to choose which track interests you most and best fits into your plans for the future.



## GLOBAL ECONOMICS

Become an expert in international economics

In this track you will study the key issues to understand how the world economy works and subject it to rigorous analysis.

In second year you will acquire the knowledge and the basic tools to conduct an economic analysis, including statistics and mathematics applied to economics. By the end of the year you will be able to **conduct your own economic analysis** in a variety of topics: among others, you will be able to **analyse a particular market, evaluate a proposal for economic regulation or conduct a**

**macroeconomic analysis of a country.**

In third year, your knowledge will take on greater depth: you will learn how to **conduct an in-depth analysis of a given market, evaluate the effects of different ways of regulating that market, and test hypotheses** using real-world data.

In fourth year you will study the last subject of your minor – Advanced Macroeconomics – and you will take your specialisation semester in one geographical area at a university

of your choice in that area, always related to your minor in Economics. You will also be able to consolidate the knowledge acquired throughout the degree by taking your internship in an international organisation or a company or institution related to your field.



## GLOBAL POLITICS

Master the key issues of world politics

In this minor you will focus on content specific to **political sciences and globalisation, international policies and conflict management**, together with **geopolitics and natural resources**.

In second year you will learn **how international conflicts are prevented** and how an **international development project** is managed from a practical point of view.

In third year you will learn the various options for **interaction between public and private organisations**, and also how to analyse the **interaction between political and economic forces**.

In fourth year you will study the last subject of your minor – Climate Politics – and you will take your specialisation semester in one geographical area at a university of your choice in that area, always

related to your minor in Politics. You will also be able to consolidate the knowledge acquired throughout the degree by taking your internship in an international organisation or a company or institution related to your field.





# Learn through multiple legal experiences

The Bachelor in Global Governance, Economics & Legal Order is based on a practical and differential methodology that will enable you to take part in several training experiences inside and outside the classroom. Each of them is designed to enrich a different aspect of your training and will allow you to put your knowledge into practice and develop skills that are only acquired by practising the profession.

## LEARNING BY DOING

This innovative methodology will bring you participate in:

### Debate leagues

Right from first year, you will have the opportunity to take part in different debate leagues. In order to participate you will take a specific course in argumentation, critical reasoning, investigation and oral resources; once the course is completed, students will be selected to form teams, and preparations will begin for the leagues in which they decide to compete.

### Model United Nations

In this prestigious university competition, recognised by the United Nations, more than 2,500 students of over 20 nationalities get to feel for a week what a session is like at one of the leading international organisations, taking part in the resolution of numerous social and political challenges.

At the last edition, the 25<sup>th</sup> Harvard WorldMUN, in 2016, **Mohamed Bouzagou**, a second-year student at ESADE Law School, won the prestigious Diplomatic Award for his success at the head of the Nature Conservancy Committee, which features the peculiarity that its members are free to move among other committees with the aim of influencing them.

### National or international internships

In addition to doing a socially-oriented internship through the SUD, in 3<sup>rd</sup> or 4<sup>th</sup> year you will be able to gain a foothold in the professional world by taking an internship in an international organisation or company related to your chosen track: the European Court of Auditors, the World Bank, UNESCO, a chamber of commerce, an embassy or a consulate-general of Spain abroad.

### Moot courts

You will have the opportunity to participate in international moot courts as of third year. Moot courts are competitions in which you will be able to experience the thrill of preparing a case and competing against teams from different universities from around the world in front of a professional panel. The Moot Court of Arbitration in Madrid, the Frankfurt Investment Arbitration Moot Court and the one with most international recognition, the Philip C. Jessup International Law Moot Court Competition, are just some of the moot courts in which ESADE students take part every year.

### Socially-oriented internships

At ESADE you will have the opportunity to offer legal advice to developing communities: during the summer of third year you will be able to take a two-month trip to Bolivia, Guatemala, Nicaragua or Costa Rica and participate in the implementation of a solidarity project through the University Development Service (SUD).

## STUDENT FIRST

### A new educational experience

Student First is ESADE's new educational methodology, an innovative system that will enable you to learn actively in collaboration with others. One of the main differences from traditional methods is that you will be required to prepare the class beforehand, by reading, researching and viewing multimedia content on a particular topic. Once in the classroom, you will share this knowledge with your fellow students and the professor by means of debates, reflections and the resolution of cases, challenges and projects.

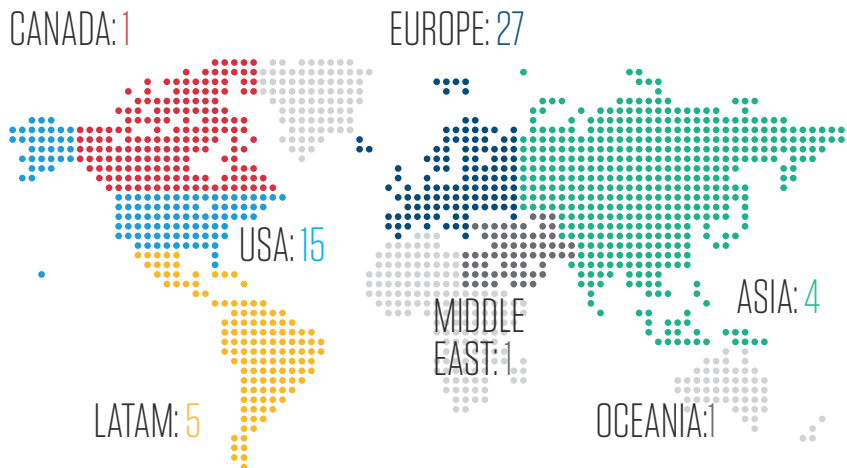

This will allow you to gain first-hand knowledge of the environment in which you are studying and to live a unique immersive experience for your learning.

You must choose one of the following: Latin America; Europe; Asia; Maghreb and Middle East; and UK, USA, Canada and Australia.

During 2nd and 3rd year you will also be able to take study tours of the main European institutions in Brussels and Madrid.

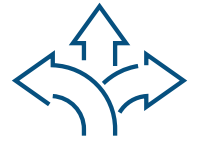
## LANGUAGES
